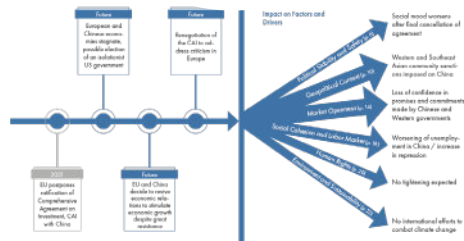

In recent years, the domestic political situation in China (Uyghurs / Xinjiang) (see 1.5 Human Rights) and China (Hong Kong) have received considerable international attention. The National Security Law for Hong Kong, which was pushed through in a fast-track procedure in June 2020, did allow the central government and the local government of the Hong Kong Special Administrative Region, which is loyal to it, to stop the large-scale demonstrations against the extradition law that had been planned since 2019¹. At the same time, this undermined the binding "one country, two systems" principle under international law in the Sino-British Joint Declaration on Hong Kong, according to which Hong Kong would still be "allowed to retain its own legal and economic system" and "its way of life" (see 1.5 Human Rights).

...er on the other is diminishing. Currently, however, this primarily affects NGOs and political actors for whom Hong Kong formerly represented a safe haven and who, after 2020, had to move to other locations in the Asia-Pacific region – especially Taiwan and South Korea². Despite the assimilation policies now implemented – including a ban on commemorative rallies, the introduction of "patriotic education" in the education system, and the closure of independent media – a serious legitimacy crisis of the Hong Kong state order remains. Although the exodus of numerous Hong Kong activists and the legal prosecution of leading figures in the protest movement who have remained on the ground have "stabilized" the situation for the Beijing leaders³, the
